Last Meeting Summar



Cannelle means cinnamon in Moroccan. Lubna Lemgard named her new restaurant, La Cannelle Café, in honor of her favorite spice. Loubna came to this country from her home in Morocco 14 years ago and moved to Wallingford three years ago. She opened her restaurant this year. It is the only restaurant in Wallingford. It currently serves breakfast and

lunch but Loubna hopes to serve dinners soon. Although most of her menu was standard fare (eggs, pancakes, salads, sandwiches), Ken Wright asked about one unusual dish – grilled haloumi and fig salad. Loubna explained that haloumi is a Greek cheese made from sheep and goat milk. A Moroccan dish is braised lamb. In answer to Rotarians' questions, Loubna said some of the problems she has faced opening and running her new restaurant include building code requirements, parking, and unreliable staff (could the staff really have that many accidents and deaths in the family?). A sign of Loubna's attention to detail is her importing whole spices and grinding them herself. This presumably includes cinnamon.

Center Revitalization presentation. One person said a problem with any plan of this type is that several of the Town Center commercial property owners are not interested in upgrading the properties. Continuing, he said some of the current property owners might have to be bought out before significant upgrades could occur. A few Rotarians stated that we as townspeople can help Town Center Revitalization by supporting changes to Borough regulations. For instance, one action is to change zoning laws to allow buildings higher than three stories in the Center. This would allow the joint commercial/residential building that was mentioned in the Task Force presentation. Another zoning change is to allow more alcohol licenses in town. The Task Force said the town could accommodate some more restaurants but these would need alcohol licenses to be successful. Current regulations allow the Inn plus two other locations to have alcohol licenses. There are already plans for the two extra licenses - the Wine Bar and the Co-op. The Co-op plan may not be accomplished because of some opposition. Another zoning change suggestion is to promote senior housing by relaxing current restrictions on unrelated adults living together. If they agree with the revitalization plan, Rotarians can support changes by advocating at zoning board and Borough Council meetings.
