Last Meeting Summary

One of David McKeighan's functions as Executive Director of the Delaware County Medical Society (DCMS) is to explain to the public the Society's position on proposed governmental actions. He shared some of these positions with us. He said

DCMS is opposed to the Pennsylvania Supreme Court allowing lawsuits to be filed in a court located in a district other than where the incident occurred. David said prior to recent reforms, lawyers could file a claim where ever they thought they had the best chance of winning. He said this practice drove up doctor's medical insurance costs. In recent years this practice of judge shopping has been restricted but there is a push to remove these restrictions. Other reforms David's Society is advocating are restricting the ability of medical insurance companies to require

prior authorization for medical treatment; excessive fees passed on to patients for "out-of-network" treatment; and allowing Certified Registered Nurse Practitioners (CRNP) to practice medicine independently. David said DCMS also has worked with communities to improve health care in the county. They have helped communities deal with the opioid epidemic by, for example, promoting coordination between municipalities. They provided aid to those who have lost relative to opioid overdoses. David told us that the Delaware County Council has hired Johns Hopkins Bloomberg School of Public Health to conduct a survey of County residents to assess how residents perceive the County to be addressing local public health needs. We can participate in two ways. We can take a brief online survey at https://tinyuri.com/DelCoSurvey or we can participate in one of several focus groups. Two are scheduled in January.
