Last Meeting Summary

Roberta Winters spoke to us about environmental "risky business" in Delaware County. Roberta is President of the Radnor League of Women Voters. Most of her talk was on the timely topic of pipelines. She acknowledged that pipelines might be better than the alternatives: transporting fuels by train or truck. Having said that, she then discussed some of the risks involved in pipelines. According to Roberta, one contributor to risks is that pipelines are regulated by many federal, state, and local agencies. Each agency regulates a different aspect of building and operating a pipeline. There is no one responsible for overall safety. She also explained that pipelines have different degrees of risk, depending on the type of material transported and the pressure inside the pipe. For example, crude oil is low risk compared to natural gas or natural gas liquids. Another factor is the age of the pipeline. Some pipelines that run through Delaware County are quite old, having been built during World War 2 (see below).

Roberta said the activity she is most concerned about is not the new Mariner pipeline but the proposed liquified natural gas (LNG) export terminal across the Delaware River in Gibbstown, N.J. She said the LNG will be transported to Gibbstown on trains and trucks, possibly through Delaware County.

Roberta mentioned, while everyone's attention is on Covid 19, that the U.S. EPA under the current administration has suspended a number of environmental regulations. I overlooked this bit of news because coverage of the numerous other events has been overwhelming all of us. Obviously, it is very disturbing.

The construction of the oil pipeline in World War 2

One of the first long oil pipelines in the U.S. was built during World War 2 between oil fields in Texas and refineries in Marcus Hook. Before the war, oil was transported by ship between Texas and Pennsylvania. After the war started, German submarines sank many ships transporting goods along the coast. This severely limited the availability of petroleum products for the war effort. The construction of the 1600 mile pipeline made a significant contribution to the availability of fuel for the economy and the military effort.

There are quite a few buried pipelines in our area. The closest is identified as containing hazardous liquid. My guess is it contains petroleum. The pipeline goes along Crum Creek parallel to the Blue Route towards Eddystone. Two branches cut off and go through Wallingford. One goes through the Springhaven Country Club. The other crosses Providence Road just south of the High School. They meet and go west. The database indicated that exact information about the location and details about the pipeline are not provided for security reasons.
