Last Meeting's Speaker: Anne Hansen By Mike Malone

Anne Hansen updated us on the RI Foundation, established after Paul Harris' death in 1947 and funded with donations in his honor. To this day it depends on the generosity of Rotarians like you.

The Ambassadorial Scholarship for \$25,000 annually continues to be a centerpiece of the Foundation. The Group Study Exchange is fully funded by the Foundation and we are expecting an incoming team from Brazil to visit our district in the spring. The Health, Hunger, and Humanitarian program exists for large grants between \$150,000 and \$300,000.

Peace Fellows is a relatively new program with 5 centers throughout the world. This year our district had a candidate accepted - a Philadelphia policeman.

Finally, we had an update to the Polio eradication efforts. Our club is #1 in the district in the last 3 years with nearly \$25,000 contributed.

A few recent outbreaks of polio were addressed by the Rapid Response team. Rotary is committed to this cause until the end.
