#### Last Meeting's Speaker: Josh Twersky By Josh Twersky

Last week **Josh Twersky** made a presentation to the club on the recently passed health care reform legislation. The legislation is one of the longest and most complex pieces of legislation in history.

He focused on particular provisions that would affect members of the Rotary Club of Swarthmore. These were primarily provisions regarding small businesses and those on Medicare.

The law and its changes go into effect immediately,however,themajorchanges take place in 2014 with the mandate that everyone have health insurance or face a monetary penalty and penalties up to \$3,000 for those employers who either do not provide any coverage or not enough coverage to employees. State run health care insurance exchanges will be created where individuals and small businesses will be able to go and shop for coverage.

Numerous tax credits will be available to offset coverage costs to those who are eligible. Medicare will be expanded for seniors.
