Are you someone who has a passion for Rotary "Service Above Self"? Are you interested in putting that passion into ACTION by serving Rotary International and our District Rotarians directly?

Each year, the Rotary Clubs of District 7450 select a "District Governor Nominee". Each Club has an opportunity to nominate one of its members for this important leadership position. This year, because of a resignation, District 7450 will select a candidate to serve as "District Governor Nominee" (serving as Governor for the 2018-19 Rotary year) and a "District Governor Nominee Designate" (serving as District Governor for the 2019-20 Rotary year).

Any Rotary Club in District 7450 desiring to nominate one of their Club members as a candidate can provide a Club resolution signed by the Club Secretary. Since we are selecting two eventual District Governors, you may select a total of two nominees from each Club, but only one nominee proposed for each of the years of service listed above.

The qualifications and duties of the District Governor are prescribed in the most recent edition of the Rotary Code of Policies and the Bylaws of Rotary International. Some qualifications to be considered are:

- Able to inspire and motivate Rotarians
- Have Goals for the District
- Be able to organize, staff and support District Committees
- Have knowledge of Rotary and the Rotary Foundation

The Nominating Committee will make its recommendation to District Governor Dave Haradon in accordance with the District Bylaws, who will then publish the selection. Clubs will then have 14 days for any challenge the nomination.

Any candidate for District Governor must be a member in good standing of a functioning Club in Rotary District 7450 and have been a member of one or more Rotary Clubs for a total of seven years at the time he or she assumes the position of District Governor. He or she must have served a full term as Club President and must demonstrate the willingness, commitment and ability (physically and otherwise) to fulfill the duties and responsibilities of the office of District Governor as provided in of the Rotary International Bylaws, section 16.090, a copy of which is attached.

The call for candidates will close on December 21, 2016.
