at Saunders House at Bryn Mawr Terrace, a rehab and nursing care facility.

Both Olive and Lori stressed the importance of networking to their success. Olive said when she started in her real estate career she refused to make cold calls but instead relied on the contacts she had made as a volunteer while she raised her family. Lori, in her fund-raising, relies on building relationships with potential donors such as patients at a hospital, alumni at a university, or frequent donors. Both women obviously have skills that will be helpful to Rotary.
